**CERTIFICATE OF PROVIDING NOTICE OF THIS COURT'S ORDER OF January 28, 2016
ESTABLISHING A MARCH 31, 2016 DEADLINE FOR FILING CLAIMS**

NOW INTO COURT, through undersigned counsel comes James J. Donelon, Commissioner of Insurance for the State of Louisiana as Rehabilitator of Louisiana Health Cooperative, through the Commissioner's Court-appointed Receiver, Billy Bostick ("LAHC"), who submit that this Court entered an order on January 28, 2016 granting the LAHC motion to establish March 31, 2016 as the deadline for submission of claims, which order required that LAHC provide notice of the entry of this Court's order of January 29, 2016 and the March 31, 2016 deadline for filing claims against LAHC to LAHC subscribers, providers, agents/brokers, vendors and general creditors.

Providers

The LAHC Receiver shows that notices of the March 31, 2016 claims deadline, as shown in attached **Exhibit A**, were mailed by United States mail, on February 4, 2016 to

- (1) 8,494 providers (284 pages of names and addresses) and on January 29, 2016
- (2) 92 direct providers and to Multi-Plan PHCS for delivery to over 14,000 providers in the PHCS network.

A copy of the affidavits verifying said mailing is attached as **Exhibit B**.

LAHC Subscribers (members), Agents, Brokers, Groups, Vendors and Creditors

The LAHC Receiver shows that notices of the March 31, 2016 claims deadline, as shown in attached **Exhibit C**, with a claim form, were mailed by United States mail, to:

- (1) 19,827 LAHC subscribers (members) on February 2 and 3, 2016'
- (2) 21 LAHC group members on February 8, 2016;

- (3) the addresses on file for LAHC subscribers were matched to the National Address Database and re-mailed to about 1700 subscribers at the new addresses provided in said database;
- (4) 180 vendors and creditors on January 29, 2016; and
- (5) to 610 agents, brokers, and agencies on February 3, 2016.

A copy of the affidavits verifying said mailings is attached as **Exhibit B**. The lists of names and addresses are not filed herewith due to privacy concerns, but are available for the Court's inspection.

The LAHC Receiver shows that notice of the March 31, 2016 claims filing deadline was published on February 8, 2016 in the New Orleans Times Picayune, the Baton Rouge Advocate, the Lake Charles American Press, the Shreveport Times, the Lafayette Advisor, the Monroe Star and the Alexandria Town Talk. A copy of the proof of publication for each news outlet is attached as **Exhibit D**.

The Receiver gives notice that LAHC has complied with the notice requirements set by this court for notifying LAHC subscribers (members), providers, vendors, agents/brokers and creditors of this Court's order of January 28, 2016 setting a claims filing deadline of March 31,
