Upon considering Milliman's request for a limited extension of time to file its writ application, and the Court concluding this motion satisfies Uniform Rule 4.3 due to new counsel,


IT IS HEREBY ORDERED that Milliman's motion for an extension of time through November 3rd, 2017 is hereby Granted.


