Following a status conference involving all counsel of record, conducted via Zoom, on May 14, 2020:

**IT IS HEREBY ORDERED** that Plaintiff's counsel shall file a status report with the Court regarding the anticipated timing and amounts of the Risk Corridor payments LAHC may receive from the federal government in the class action suit entitled "Health Republic Ins. Co. v. United States of America", case no. 1:15-cv-00259 pending in the Court of Federal Claims as a result of the *Maine Community Health Options* opinion of the Supreme Court, on or before June 15, 2020.

**IT IS FURTHER ORDERED** that the motion to compel against LAHC filed herein by GRI on May 11, 2020, shall be set for hearing before the next status conference scheduled for July 16, 2020; **IT IS FURTHER ORDERED** that, in relation to GRI's motion to compel, the Court shall set a filing deadline in advance of the hearing date regarding GRI's motion to compel that will allow other defendants to submit briefing prior to the hearing, and set a date for LAHC to respond prior to the hearing.

**IT IS FURTHER ORDERED** that a status conference, to be conducted via Zoom, with all counsel shall be held on July 16, 2020, at 10:00 a.m.






