NOW INTO COURT, through undersigned counsel, comes James Donelon, Commissioner of Insurance for the State of Louisiana, in his capacity as Rehabilitator, (hereinafter referred to as "the Commissioner"), and Billy Bostick, Court appointed Receiver, of Louisiana Health Cooperative, Inc. in Rehabilitation ("LAHC"), who hereby moves this Honorable Court for an Order approving an the Contract For Professional Services with Antares, LLC dba Antares Technology Solutions ("Antares") for the following reasons:

1.

La. R.S. 22:2018 provides that in proceedings involving only domestic insurers, the Commissioner of Insurance may employ such assistants as he deems necessary. The provision allows the Commissioner to appoint one or more deputies as his agent or agents and to employ such clerks, or assistants as may by him be deemed necessary, and to give each such person such powers to assist him as he may consider wise.

The Commissioner and the Receiver deems it necessary to contract with Antares to provide information technology services that are requested by the Receiver on behalf of the estate of Louisiana Health Cooperative, Inc. in Receivership. A copy of the Contract is attached as **Exhibit "A"**.

As required by LSA-R.S. 22:2018, the Commissioner requests that this Honorable Court approve the Contract for Professional Services between the Commissioner and Antares.






ORDER


