MOTION AND INCORPORATED MEMORANDUM TO PERMIT LAHC APPROVAL AND IMMEDIATE PAYMENT IN FULL OF LAHC PROVIDER CLAIMS FOR REMAINING UNPAID CLAIMS WITH SERVICE DATES PRIOR TO JANUARY 1, 2016 (the "Round Four LAHC Providers")

NOW INTO COURT, through undersigned counsel comes James J. Donelon, Commissioner of Insurance for the State of Louisiana as Rehabilitator of Louisiana Health Cooperative, Inc. in Rehabilitation, through the Commissioner's Court-approved Receiver, Billy Bostick ("LAHC"), who seeks an order of this Court approving LAHC approval and immediate payment in full of the remaining LAHC Provider Claims with service dates prior to January 1, 2016 (when all LAHC coverage ended) identified by LAHC after the March 31, 2016 claims deadline but for which LAHC provided coverage (the "Round Four LAHC Providers").

Background

Since LAHC's receipt of a federal release and the Court's approval of payment in full to LAHC Class 1, 2, 3, and 4 claims pursuant to La. R.S. 22:254(G), LAHC has been distributing payment to the Round One, Round Two and Round Three LAHC Providers and LAHC member claims.

The Group Four LAHC Providers

The subject of this motion are the claims of approximately 243 LAHC Providers/Provider Groups with outstanding claims for services provided to LAHC member prior to the termination of coverage on December 31, 2015 and identified by LAHC as valid claims for which payment is owed, which, in total, amounts to approximately \$600,000. These claims were submitted to LAHC after

(1) The commissioner's costs and expenses of administration, which are ongoing;

(2) Compensation owing to employees with nothing outstanding owed;(3) Claims for covered benefits (which include the claims of LAHC Providers;

Class 5 claims are the claims of LAHC general creditors. The United States has collected all money due from LAHC, other than for the LAHC Solvency Loan, pursuant to a court approved stipulation for Risk Corridor funds paid to LAHC..

⁽⁴⁾ Claims for unearned premiums (nothing is due as premiums were collected monthly and ended on December 31, 2015) and claims for "other premium refunds" which are generally the claims of LAHC members who overpaid premiums, estimated to be less than \$150,000, which have already been approved by the Court for payment.

As to these anticipated 243 Round Four LAHC Providers, LAHC seeks authority to continue to contact each Round Four LAHC provider, obtain executed LAHC Settlement documents approved by the Court where warranted, and put the Round Four LAHC Providers in line for payment of the full amount determined to be due and/or agreed to, without the necessity of Court approval prior to payment, but with periodic reports to the Court on all such finalized Round Four LAHC Settlements. Payment to these Round Four LAHC Providers without prior to Court approval will permit LAHC to make long overdue payment to these Round Four LAHC Providers on an expedited basis as each is finalized by LAHC.

As before, LAHC requests authority to make agreed upon changes to the LAHC Settlement Plan documents as needed and to enter into such confidentiality and non-disclosure agreements as may be needed and /or prudent.

For all these reasons, LAHC asks the Court to approve the plan to permit LAHC approval and immediate payment of the amounts due to the Round Four LAHC Providers with anticipated total payment of approximately Six Hundred Thousand (\$600,000.00) Dollars without the necessity of prior court approval as a modification to the LAHC Settlement Plan previously approved by the Court.

WHEREFORE, LAHC prays for entry of an order granting this motion and ordering same implemented as follows:

- Authorizing and directing LAHC to contact Round Four LAHC Providers and to send the LAHC Settlement documents to the Round Four LAHC Providers where LAHC deems necessary.
- Obtain signed LAHC Settlements from the Round Four Providers where LAHC deems necessary and to put the Round Four LAHC Providers in line for immediate payment of the full amount LAHC determines is due, without the necessity of Court approval prior to payment, but with periodic reports to the Court on all such finalized Round Four LAHC Settlements to permit LAHC to make long overdue payment to these Round Four LAHC Providers on an expedited basis;
- 3) As before, LAHC requests authority to make agreed upon changes to the LAHC Settlement Plan documents as needed and to enter into such confidentiality and non-disclosure agreements as may be needed and /or prudent;
- 4) That in all other respects the LAHC Settlement Plan approved by the Court on December 3, 2018, as subsequently amended by later orders of this Court, remain in full force and effect as to all LAHC Providers, including any and all Round Four LAHC Providers; and
- That the LAHC Receiver be granted all power and authority to accomplish the task of implementing the LAHC Settlement Plan for the Round Four LAHC Providers and to execute any documents related thereto as the Receiver may deem necessary and advisable in the Receiver's discretion, and for such other relief as warranted.

IT IS FURTHER ORDERED, ADJUDED AND DECREED that LAHC authorized to make agreed upon changes to the LAHC Settlement Plan documents as needed and to enter into such confidentiality and non-disclosure agreements as may be needed and /or prudent.


