Donelon, Commissioner of Insurance for the State of Louisiana as Rehabilitator of Louisiana Health Cooperative, through the Commissioner's Court-appointed Receiver, Billy Bostick ("LAHC"), who submit that this Court entered an order on October 28, 2015 granting the LAHC Motion to Approve Plan for Publication and Distribution of Notice of Rehabilitation and Cancellation of Coverage to Policyholders, Members, Enrollees and Subscribers, and Notices of Rehabilitation to Brokers/Agents, to Vendors and to Providers and approving the plan to send notices to each of the four (4) groups in the form approved by the Court by United States mail with proof of mailing and to provide notification of the cancellation and termination of all LAHC policies as of December 31, 2015.

The order entered on October 28, 2015 in this matter also approved the LAHC plan to publish notice of the LAHC rehabilitation in local newspapers in Baton Rouge, New Orleans, Lafayette, Alexandria, Monroe, Shreveport and Lake Charles, Louisiana to ensure the widest possible distribution of notice to LAHC policyholders, members, enrollees, and subscribers, LAHC agents/brokers, LAHC vendors, and LAHC providers.

The LAHC Receiver shows that on or about October 30 and November 2, 2015 the approved notices, copies of which are attached as Exhibit A (LAHC Members), Exhibit B (LAHC Agents/Brokers), Exhibit C (LAHC Vendors), and Exhibit D (LAHC Providers) were mailed by United States mail, to each person, group and/or business entity appearing on the books and
