MOTION TO APPROVE AMENDMENT TO THE CONTRACT FOR
PROFESSIONAL SERVICES OF BOSTICK CRAWFORD CONSULTING GROUP, LLC

NOW INTO COURT, through undersigned counsel, comes James Donelon, Commissioner of Insurance for the State of Louisiana, in his capacity as Rehabilitator of Louisiana Health Cooperative, Inc. in Rehabilitation, through the Commissioner’s Court appointed Receiver, Billy Bostick (“LAHC”), who respectfully submits this Motion to Approve an Amendment to the Contract for Professional Legal Services with Bostick Crawford Consulting Group, LLC (“BCCG”). In support of this motion, LAHC avers as follows:

1.

BCCG provides services to LAHC in the above-captioned matter pursuant to a Contract for Professional Services approved by this Court on October 15, 2015 (the “BCCG Contract”).

2.

On or about February 8, 2016, the Louisiana Department of Insurance approved changes to the maximum hourly fee schedule for professional services provided by contractors such as BCCG.

3.

Since the outset of this receivership, BCCG has been compensated at the hourly rates that were effect on **April 23, 2014**. See Exhibit 1, Appendix “C” to the BCCG Contract. Per the terms of BCCG contract, LAHC may modify the hourly rate paid to BCCG subject to the approval of the Court.” LAHC seeks to amend Appendix “C” of the contract with BCCG to allow for BCCG to be compensated according to the current fee schedule adopted in 2016. A copy of the proposed amendment titled “Amended Appendix ‘C’” is attached as Exhibit 2.

4.

LAHC submits that BCCG’s work on this receivership to date has been exemplary and warrants compensation at the rates provided in Exhibit 2. LAHC also projects that LAHC will have

sufficient assets to compensate BCCG at the rates provided in Exhibit 2 through the conclusion of this receivership. LAHC believes the proposed level of compensation is fair and reasonable and is in LAHC's best interest.

WHEREFORE, LAHC respectfully requests that this Court grant his motion and approve the proposed amendment to the Receiver's Contract for Professional Services with BCCG.


ORDER
