Please read this notice carefully as it provides important information in connection with your policy or policies.

You are receiving this notice because the records of **Mothe/DLE** Life Insurance Company indicate you have or had an insurance policy or multiple policies with one or more of the above mentioned Companies.

This notice is to inform you that **Mothe/DLE** is operating under a Consent Order of Rehabilitation entered on October 2, 2014 by the 19th Judicial District Court located in Baton Rouge, Louisiana and are now under the direction and control of the Louisiana Department of Insurance, through its Commissioner, James J. Donelon, and myself as the court appointed Receiver.

Under the Consent Order of Rehabilitation and Louisiana law, the Rehabilitator and his Receiver have been directed to conduct all of the business and affairs of **Mothe/DLE** as they may deem appropriate, until further order of the Court.

STATUS OF YOUR POLICY

All existing policies are **NOT** cancelled by the rehabilitation order.

PREMIUM PAYMENTS

If your policy is not paid up, you must continue to make your regularly scheduled premium payments to avoid cancellation of your policy. If your policy is paid up, you are not required to do anything with respect to your policy at this time.

POLICY LOAN REPAYMENT

If you obtained a loan from **Mothe/DLE** on the security of your policy, you will receive a separate letter outlining repayment obligations.

POLICY LOAN AND CASH SURRENDER MORATORIUM

As of October 2, 2014, by Court order, a moratorium has been placed on the right to take a loan on your policy, or surrender your policy for cash. This moratorium period <u>does not</u> apply to the payment on death claims. **Mothe/DLE** <u>will</u> continue to pay death claims per the terms of your policy.
