MISSION -

The Louisiana Health Care Quality Forum is a private, not-for-profit organization dedicated to leading evidence-based, collaborative initiatives to improve the health of Louisiana residents.

– OVERVIEW –

The Louisiana Health Care Quality Forum was formally recognized in 2007 by the State Legislature to plan, promote and lead quality improvement initiatives in our state. As a neutral convener led by a volunteer board, the organization's initial focus was the transition to patient-centered models of care delivery to improve quality and outcomes while reducing costs. This focus quickly expanded to include other clinical quality improvement measures and an emphasis on the collection and analysis of trusted, actionable health care data as well as outreach and education to support patient engagement and empowerment.

By 2008, it had also identified health IT as a major need in Louisiana. In 2010, the organization was awarded \$18.4 million in federal grant funds to establish a Regional Extension Center (REC), the Louisiana Health Information Technology (LHIT) Resource Center, to assist the state's health care providers in the adoption and meaningful use of electronic health records (EHRs), and to implement the Louisiana Health Information Exchange (LaHIE).

The Quality Forum also adopted the Louisiana Physician Orders for Scope of Treatment (LaPOST) program as one of its initiatives in 2010. Approved as Act 954 in the 2010 regular session of the

State Legislature, LaPOST is an evidence-based model designed to improve end-of-life care for those with serious, advanced illnesses.

The Quality Forum's focus areas have overlapped and aligned, yielding a comprehensive and integrated approach to improving health care quality, value and outcomes in Louisiana.
